Description: **VICTIM ADVISED THIS TAG WAS ON THE VEHICLE USED TO GET AWAY****Narrative**

On Saturday, September 19, 2009, at 0421 hours, I responded to the tower III lobby to investigate a call in reference to a battery.

I met with Eric Britt, who advised on 09/19/09, at approximately 0400 hours, he was dropped off in front of Tower III on the East Plaza Dr side. Britt told me he was confronted by two white males both wearing white t-shirts; one had yellow jersey style shorts and the other regular shorts. He said both were average height and weight. Britt told me he was asked several questions by these two individuals (see statement) and then was punched closed handed in the mouth. Britt then said he was grabbed by the neck and both individuals proceeded to punch him. Britt told me he managed to get away from them and he ran towards the Tower III doors yelling for help. Britt told me the two individuals ran away and got into what he thought was a [REDACTED]. Britt also told me he felt he was targeted because he was dropped off by a male and because of his sexual orientation. Britt told me he did not know the individuals and did not give them permission to strike him. He is willing to prosecute.

The tag number Britt gave came back to a [REDACTED]. The vehicle is not registered on campus and the registered owner is not a student or has any affiliation with the University. I did not see any visible marks on Britt. He was holding a cold pack to his mouth. I asked him if he was cut and he said "no". I asked if he needed medical attention and he said "no".

At this time the two individuals remain unidentified and there is no further information. Britt was given a UCF business card referencing the case number and a Victims Rights Pamphlet.
